Maurice C. filed this petition for a
writ of habeas corpus, claiming
that he was denied due process

when the trial court failed to afford him adequate notice of its decision to merge the convictions into one sentence. The petitioner has failed to prove that the state's adjudication of his claim in a habeas proceeding was improper.

Accordingly, we dismiss the petition. We set forth the following relevant facts. The petitioner was convicted of two counts of robbery in the second degree in violation of General Statutes § 53a-135(a)(3).

Both convictions stemmed from the same conduct, which occurred

on March 10, 2000, at approximately 3 p.m. A sentencing hearing was held on May 1, 2000.

At the conclusion of the proceeding, the court, Hon. Edward J. Fazzano, judge trial referee, sentenced the petitioner to a total effective term of six years imprisonment. On June 27, 2000, the petitioner filed a motion for correction of illegal sentence, which he subsequently withdrew in a letter dated September 12, 2000.

On June 22, 2001, the petitioner again filed a motion for correction

of illegal sentence, which was denied in a decision dated March 3e33713323
