# GOVERNMENT INITIATIVES SUPPORTING THE MINERAL FUELS EXPORT OF HUNGARY IN 2024

The National Energy Strategy 2030, launched by the government authorities, has focused on energy security and diversification. It is designed to promote the modernization of the fuel infrastructure while enabling Hungary to continue its role as a regional hub. The Refinery Development and Modernization Program was further initiated to upgrade the collaboration with MOL Group for increasing the production of high-grade refined fuels while boosting export volumes.

The Natural Gas Storage and LNG Infrastructure Initiative has improved Hungary's ability to re-export natural gas for maintaining stable supply routes. The cross-border energy cooperation framework has strengthened energy ties with Slovakia for enhancing the regional energy trade integration to promote smoother and efficient export flows. The Investment Incentive and Trade Facilitation Policy were introduced by the government authorities to promote tax relief subsidies for the active attraction of foreign direct investment. It has eventually improved the logistics infrastructure while increasing Hungary's overall mineral fuel export capacity.
